Our labor and road rate is \$105.00 per hour, prevailing wage jobs will be billed according to their respective hourly rates. Our road rates are based on portal to portal travel times. Our regular hours are Monday- Friday 7:00 AM to 3:30 PM. Any hours worked outside of these are billed at time and a half. There is also a \$2.25 per mile charge for travel to and from job site.

Rates are based on a normal 40 hour work week. If work is to be performed on holiday or weekends, rates will be based on time and one half and/or double time.

Invoices are issued upon completion of services. Once credit is approved, payment terms are net 10 days. A 10% late charge will be added on to any unpaid invoice after 30 days and a 1% every month thereafter. **If you are a new Customer, payment terms are C.O.D. until your account has been approved, and payment in full is expected upon presentation of invoice.**
